



# 2018 INBOUND ROUTING GUIDE

- I. **Small Parcel:** Ship orders weighing 150 lbs or less via UPS. Third party bill to the account number provided on the Victor Technologies purchase order.
- II. **LTL:** For orders 151 lbs to 19,999 lbs (or up to 20 Linear feet of the trailer) use the routing below for correct carrier selection.
- III. **Truckload:** 20,000 lbs or more or over 20 linear feet of the trailer) call the Logistics Department at 940-381-1311 for routing instructions.
- IV. **Air Freight:** Only as instructed by ESAB.
- V. **Payment:** Bill of Lading must be marked “3rd party” to ESAB / Victor Technologies, c/o US Bank, PO Box 3001, Naperville, IL 60566-7001

Effective for shipments on or after 02-03-18. Deviation from these routing instructions will result in a chargeback to cover the difference in freight paid.
